#### U.S. Personal Care M&A & Private Placement Commentary


After a sluggish M&A environment persisted throughout 2023, M&A volume in the Personal Care industry has accelerated in early 2024, with 14 transactions closed during Q1 2024 compared to just 7 in Q1 2023.

Early 2024 saw several strategic acquirers within the Beauty sector utilize M&A as a strategy to diversify brand portfolios and expand product categories. Examples include Unilever's acquisition of haircare brand K18, Shiseido's acquisition of skincare brand Dr. Dennis Gross Skincare, and Puig's acquisition of skincare brand Dr. Barbara Sturm.


With the global Vitamins, Minerals & Nutritional Supplements sector forecast to grow at a CAGR of 9.1% from 2024 to 2030, private equity groups continue to make add-on acquisitions of contract manufacturers to increase production capacity and expand manufacturing capabilities across various product formats. One recent example is Heartwood Partners' portfolio company Somafina's acquisition UST Corporation.

Contract manufacturers and packaging companies continue to cite optimism in Personal Care end-markets, as volumes have generally remained flat to modestly up. New product innovations and campaigns are spurring additional designs, artwork, and packaging formats which bode well for both contract manufacturers and packaging materials companies.
